PARENTS' (legal guardians') DECLARATION:

All of the information stated herein is true. We are aware that giving false information that may affect the child's preschool admission can lead to a revision of the admission decision made with respect to the requirements listed herein. I hereby authorize the preschool to process and keep the records of my child's personal data and sensitive personal data, in accordance with the provisions of Act No. 101/2000 Sb. on Personal Data Protection, as amended. This authorization is granted for the purposes of recordkeeping requirements for schools under Act No. 561/2004 Sb. on Education, as amended, for medical record keeping and psychological examination requirements, for the purposes of extracurricular activities such as school trips, outdoor activities, accident insurance for children, and for other purposes associated with the day-to-day school functioning.

This authorization shall remain in effect for the duration of my child's enrolment at the aforementioned preschool and for the applicable statutory retention period. This authorization applies solely to the aforementioned preschool, which is prohibited from sharing personal and sensitive data with any other parties or authorities, except where expressly provided for by law. I acknowledge the rights under Act No. 101/2000 Sb., specifically the right to withdraw my consent at any time without justification.

The legal representative is obliged to immediately notify the Preschool Director of any existing orders for custody and provide the corresponding court's decision. A copy of the court's decision shall be attached to this application (the parent is obliged to provide the original copy of the decision at the moment of enrolment). In accordance with Section 36 (3) of the Administrative Procedure Code 500/2004 Sb., as amended, legal representatives have the right to express their opinion regarding the grounds for the decision, before the decision in this preschool admission proceeding is made.

The grounds for decision may be accessed and commented on 29th May 2023 from 9 am to 11 am, in the Preschool Director's office. The legal representative shall provide a proof of identity upon request of an authorized person.
